- 2.2.2 The Quarterly Lucky Draws will be conducted at the end of each quarter (i.e. in August 2019, November 2019 and March 2020) during the Campaign Period.

2.3.2 The Grand Draw will be held after the end of the Campaign Period, at a Grand Draw Event, which will be announced at a later date.
